ColorCodeIT is cloud-based software that calculates real-time updates on an organization's regulatory or other compliance status, mapped to the exact language elements of the compliance standards themselves. AI and Natural Language Processing assist the standards parsing process, generating color-coded templates with core language metrics.

During implementation, one-to-one mapping to the organization's digital evidence is completed. The organization's updated files are tracked to sustain compliance on an ongoing basis. Audit work papers are auto-populated from the database. Integrated risk is monitored on a calculative basis via live dashboard reporting, performing months of work by multiple resources in a fraction of a second.
